AN ORDINANCE AMENDING BOARD OF HEALTH FEES
AND AMENDING CHAPTER BH:VII AND CHAPTER BH:XII OF THE REVISED
GENERAL ORDINANCES OF THE BOARD OF HEALTH**

BE IT ORDAINED by the Board of Health of the Township of Long Hill, in the County of Morris, State of New Jersey, that Chapter BH:XII of the Revised General Ordinances of the Board of Health is amended as follows:

Section 1. Subparagraph "a.2" of section BH:XII-1 entitled "Schedule of Fees for Board of

Health Functions” is amended to read as follows:

BH:12-1 SCHEDULE OF FEES FOR BOARD OF HEALTH FUNCTIONS.
