PLANNING BOARD MINUTES OF THE REGULAR MEETING/HEARING February 8, 2022

The Long Hill Planning Board met for a Regular Meeting/Hearing via online virtual meeting format using Zoom Webinar.

At 7:32 pm, Chairman Sandow called the meeting to order and Board Secretary Coonce made the following announcements:

Minor Site Plan (Carried from 11/23/21 & 1/11/22) Block 10910 / Lot 15 / Zone B-1-20 342 Valley Road (Chimney Rock Pump Station) Application No. 21-16P <u>New Jersey American Water Company, Inc.</u> Applicant proposes to install a new/replacement 6' high

Applicant proposes to install a new/replacement 6' high chain link fence with black privacy slats, adding a fourth side to completely enclose the pump station and a double swing gate for access.

Victoria Siegel, Esq. appeared on behalf of the Applicant.

Witnesses that were sworn in to offer testimony on behalf of the Applicant: Michael Nexon, as Engineer No members of the public were present with questions or comments for the Applicant and their witnesses.

During discussion, the Board thanked the Applicant and their professionals for taking into consideration the concerns of the members of the Board to make sure that the new fence and landscaping are maintained and visually pleasing for the street scape and community.

Upon motion made by Mr. Pfeil and seconded by Committeeman Rae, the application was approved with conditions subject to a memorializing resolution by the unanimous votes of Mr. Pfeil, Committeeman Rae, Committeeman Verlezza, Ms. Dill, Mr. Hands, Mr. Malinousky, Vice Chairman Richardson and Chairman Sandow; they being all members present and eligible to vote.

Upon motion made and seconded, the meeting minutes of January 25, 2022 were approved as amended.

(8) Master Plans Discussion (7:59 pm) –

Vice Chairman Richardson presented the Board with a proposed schedule regarding review and public hearings for the Master Plan completion. VC Richardson further noted the Master Plan Committee has broken down what work remains by specific tasks with the first task to be completed by the end of March. Task 2 involves plan recommendations, elements that will be focused on, and eventually goals to return to the Board with first sets of recommendations in May. The MPC will break down the recommendations for the Board's review from May to September with public hearings to follow.
