**ROLL CALL:** Mayor Piserchia, Deputy Mayor Dorsi, Committeeman Meringolo, Committeeman Rae and Committeeman Schuler were present. Also present were Attorney Jack Pidgeon, Administrator Nancy Malool and Township Clerk Deborah Brooks.

**LIAISON REPORT:**

Committeeman Meringolo: Reported that the next edition of the newsletter is coming up and any suggestions for articles are welcome.

Committeeman Schuler: No report.

Deputy Mayor Dorsi: Thanked the Fire Departments and mutual aid services for doing a good job at the fire this past Saturday.

Committeeman Rae: Reported HPAC's July 11<sup>th</sup> meeting was cancelled and rescheduled for August 1<sup>st</sup> at which time the June 27<sup>th</sup> Historic Society's presentation regarding the Milling Schoolhouse will be discussed.

**PRESENTATION: AUDIT REPORT** – John Mooney, Nisivoccia

Mr. Mooney gave a brief synopsis of the 2017 audit and answered questions from the Committee.

**ADMINISTRATORS REPORT:**

- Ms. Malool and Acting DPW Dir. Gallo had met with JCP&L representative Rob Walton to discuss the costs of running electric for a new light at the Gillette Train Station. It will be approximately \$2000. Ms. Malool is gathering prices on different size poles and will come back to the Committee with final pricing for adding a light to the train station.
- NJAW has begun a \$700,000 water main replacement project on Essex Avenue that should be completed by Labor Day.
- A multi street paving project will start on Monday, July 23 and should be completed in 8 days. The streets involved are Church Rd, Highland Ave., Hilltop Rd., Home St., Midvale Ave., Lower Overlook Rd., Passaic St., Skyline Dr., Stonehouse Rd., and Riverview Dr.
- The cleanup of vegetative waste in Central Park has been completed. After DEP inspection and approval the \$30,000 being held from the flood acquisition project should be given to the Township.
- Ms. Malool and the Dir. Of Recreation, Lisa Scanlon have continued discussion of the two proposed Dog Park sites to be fully discussed at the August 15<sup>th</sup> meeting. Ms. Malool reviewed the approximate costs of each project: \$15,000-\$20,000 for the site located behind Town Hall and \$50,000 to \$75,000 for the Laura Drive site.
- Tax Bills will be going out a little late due to the change in state funding in the latest budget and state aid given to the High School district. The Board of Education met last night and determined the aid will not go toward tax relief. The new bills should be issued within two weeks and there will be the usual grace period allotted.
- Sewer bills went out last week, August 20<sup>th</sup> is the deadline for payment with no penalty.
- Oaks Road paving, curbing and drainage project has been awarded.
- Ms. Malool spoke with Ms. Grillo regarding the Veterans Banner project. They will meet in the beginning of August to discuss the use of the lamp poles on Main St. to hang the banners. This will necessitate the use of a smaller banner than originally suggested.
- After a citizen had reported line of sight concerns on Mountain and Long Hill Road, a 400' area of Mountain has been cleared and the County is going to look into moving the existing stop sign forward for a better line of sight.

**WHEREAS**, Resolution 17-322, adopted December 29, 2017, authorized the Township to enter into a Memorandum of Understanding (“MOU”) with Community Options to develop a group home at property which is identified in the MOU, but which has been redacted until Community Options enters into a contract to purchase the property; and

**WHEREAS**, under the terms of the MOU, the Township agreed to contribute \$75,000 in affordable housing trust funds toward the development of the project; and

**WHEREAS**, it has been determined that an additional \$25,000 contribution is needed to make the project financially viable;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Long Hill in the County of Morris, State of New Jersey, as follows:

1. The Memorandum of Understanding with Community Options as authorized by Resolution 17-322 is hereby amended by increasing the Township’s contribution from \$75,000 to \$100,000.
2. If this project comes to fruition, the Township’s contribution will be appropriated from the Affordable Housing Trust Fund.
3. In all other respects, the MOU shall remain unchanged.

**RESOLUTION 18-215  
GOVERNING BODY CERTIFICATION OF THE ANNUAL AUDIT**

**WHEREAS**, N.J.S.A. 40A: 5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

**WHEREAS**, the Annual Report of Audit for the year 2017 has been filed by a Registered Municipal Accountant with the Township Clerk pursuant to N.J.S.A. 40A: 5-6, and a copy has been received by each member of the governing body; and

**WHEREAS**, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

**WHEREAS**, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations; and

**WHEREAS**, the members of the governing body have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and

**WHEREAS**, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

**WHEREAS**, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

**WHEREAS**, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

**DISCUSSION:**

- Rolling Knolls Landfill Remediation – GSWA Executive Director Sally: Mayor Piserchia, as a member of the GSWA Board, recused himself at this point and left the room. Ms. Rubin requested the Committee support adding the idea of remediation, by putting contamination waste in a deep clay hole, to the EPA’s final list of possible remediation solutions. She recommended the Committee send a letter to the EPA offering such support and would send Ms. Malool the letter Harding Township used as a sample. Moved by Committeeman Rae, seconded by Committeeman Meringolo, and passed unanimously, the Committee directed Ms. Malool to send the supporting letter to the EPA.
- AT&T requesting a monopole or flagpole in Long Hill Township, specifically in the area of The Millington School House 1820 Long Hill Road or the Hicks Tract. After a brief discussion, the Committee directed Ms. Malool to respond to the request, rejecting the Millington School site and noting they would be willing to consider the Hicks Tract Park location if AT&T got approval from the state since Hicks Tract is in Green Acres: The Committee suggested AT&T investigate the possibility of installing a pole at The Shrine of St. Joseph.
- Stirling Lake Vendors – this discussion was moved to the August 15<sup>th</sup> meeting.
- Turtle Rock Park: The Committee rejected the request of the HPAC to cover the expense of a second bench in Turtle Rock Park. The bench was originally to be donated but the donor pulled the donation. The Committee felt the table, one bench, a trash and recycling receptacle would be

enough.

- Vacant/Abandoned Property Ordinance- This ordinance would require owners of abandoned property to register with the Township and will be introduced at the next meeting.
- Stirling Train Station Parking Lot/Railroad Avenue Parking: After discussion the Committee directed Attorney Pidgeon to have an Ordinance ready for Introduction at the next meeting which would allow non permitted parking in the Stirling Train Station after 4pm. This would hopefully alleviated the parking situation on Railroad Avenue. Additionally there was discussion of changing the duration of street parking on Main Street and widening Railroad Avenue to the ROW maximum.

**OLD BUSINESS/NEW BUSINESS:**

- Committeeman Rae reported that the Township's "A Way Out" Committee and the County CARES committee are working together jointly and encouraged any residents dealing with addiction to reach out to the "A Way Out" Committee members for expeditious help.

**MEETING OPEN TO THE PUBLIC**

- Tom Grosskopf thanked Ms. Malool for her continued effort in working toward getting an additional light at the Gillette Train Station. He offered no parking on the north side of Railroad Avenue from 5pm to 5am as a solution to the Railroad Avenue parking issue.
- Dennis Sandow noted 7 or eight years ago there was a proposal to put a tower in the back of the Runion(sp?) property to help with consistent service along the train route. He suggested some of the other Open Space properties can be considered for the Dog Park and reminded everyone that the next Freedom Tour is 376 days away.
- Charles Arentowicz wondered what other NJAW capital improvement projects the residents of Long Hill are funding, noted the Township spent money over the allotted \$10,000 for the cleanup of the vegetative waste on the land division property and said the Town's street lights were very cheap looking and he wouldn't want his veteran's banner to be hung on one.
- Chris Ratti voiced concern over his ability to continue the operation of his business during whatever new construction occurs on the Valley Road Redevelopment property. He was assured his business would be continue to be able to function.

On motion by Mr. Meringolo, seconded by Mr. Dorsi, all in favor, the meeting was adjourned at 9:33pm.
